ENTRY REQUIREMENTS

Applicants must possess **ONE** of the following qualifications:

- A **Master's Degree in a relevant field** or a field recognized by the Senate of Universiti Tun Hussein Onn Malaysia; **OR**
- Other qualifications equivalent to a Master's Degree recognized by the Senate, subject to a minimum of **3 years of relevant work experience** and **thorough internal evaluation**; **OR**
- Without relevant qualifications in the field or relevant work experience, must **meet the prerequisites** set by UTHM.
- This programme also accepts students through **APEL.A T-8** for those who do not have a master's degree, in accordance with the criteria set by the MQA.

ENGLISH REQUIREMENTS

1. Local and international applicants who have **graduated from universities in Malaysia** are **exempt** from the English requirements.
2. International applicants must have a minimum English qualification of **IELTS level 6.0, MUET Band 4.0**, or an equivalent standard.
3. International applicants who have **graduated from universities in designated English-speaking countries** may also be **exempt** from the requirement.
